Compulsory site briefing session will be held at the uMfolozi Municipal Hall, 25 Bredelia Street, Kwa-Mbonambi where prospective bidders will proceed for site inspection. Bidders that do not attend the meeting will be disqualified. Documents will be available from the 30<sup>th</sup> of August 2016. A non-refundable tender deposit of R 250.00 per tender payable in cash or by a bank guaranteed cheque made out in favour of uMfolozi Municipality is required on collection of the tender documents. **No documents will be sold at the briefing session.** Only Service Providers with valid documents will be allowed at the briefing session.

**NOTE:** Contractors who previously bought tender documents need not buy again, however will need to collect new tender documents and will need to produce their original receipt in order to receive the new tender documents.

**EVALUATION CRITERIA:** Bids will be evaluated using 90/10 principle of the Preferential Procurement Policy Framework Act, 2000 (Act No.5 of 2000) and including the BBBEE (Act No. 53 of 2000).

**CLOSING DATE:** Tenders are to be submitted in a sealed envelope, clearly marked with the relevant tender description and tender number, and must be placed in the tender box at the Municipal Offices, 25 Bredelia Street, Kwa-Mbonambi, on or before 12h00 on the 20<sup>th</sup> of September 2016 when they will be opened in public. Bids received after the closing date will not be considered. Facsimile and e-mail tenders will not be considered. The lowest or any other tenders may not necessarily be accepted by the municipality.

Bids shall remain valid for a period of 90 days from the closing date.
