CLOSING DATE: Tenders are to be submitted in a sealed envelope, clearly marked with the relevant tender description and tender number, and must be placed in the tender box at the Municipal Offices, 25 Bredelia Street, Kwa-Mbonambi, on or before **12h00 on the 04th of March 2016** when they will be opened in public. Bids received after the closing date will not be considered. Facsimile and e-mail tenders will not be considered.
