

## BID NOTICE RE-ADVERTISEMENT

## PROVISION OF SECURITY SERVICES FOR A PERIOD OF 36 MONTHS. BID NUMBER: MBO/502/2017

Bids are hereby invited in terms of Section 110 of the Local Government: Municipal Finance Management Act 56 of 2003 read with the uMfolozi Municipality Supply Chain Management Policy for the Provision of the following Services:

SCOPE OF WORK: Provide security services for uMfolozi local municipal offices, waste transfer station, fire services, Thusong Centre and provision of VIP close protection services for a period of Thirty Six (36) Months.

Compulsory site briefing sessions will be held at Municipal Council Chambers, 25 Bredelia Street, Kwa-Mbonambi, starting at 10h00 on the 20th of February 2018 where prospective bidders will proceed for site inspection. Bidders that do not attend the meeting will be disqualified. Documents will be available from the 12th of February 2018 and must be purchased prior to the briefing session. A non-refundable tender deposit of R 250.00 per tender payable in cash or by a bank guaranteed cheque made out in favour of uMfolozi Municipality is required on collection of the tender documents. Only Service Providers with valid documents will be allowed at the briefing session, NB: Service Providers who previously bought the tender documents will receive the new tender documents free of charge. No documents will be sold at the briefing session.

EVALUATION CRITERIA: Bids will be evaluated using the 80/20 principle of the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000, Preferential Procurement Regulations 2017) and including the BBBEE (Act No. 53 of 2000).

CLOSING DATE: Tenders are to be submitted in a sealed envelope, clearly marked with the relevant tender description and tender number, and must be placed in the tender box at the Municipal Offices, 25 Bredelia Street, Kwa-Mbonambi, on or before 12h00 on the 28th of February 2018 when they will be opened in public. Bids received after the closing date will not be considered. Facsimile and e-mail tenders will not be considered. The lowest or any other tenders may not necessarily be accepted by the municipality.

Bids shall remain valid for a period of 90 days from the closing date.
