Bidders that do not attend the meeting will be disqualified. Documents will be available from the 03rd of July 2015 and documents must be purchased prior to the briefing session.

Documents shall be sealed in an envelope clearly endorsed with the bid number for the relevant project e.g. MBO/305/2015: "CONSTRUCTION OF NTOYENI HIGH MAST LIGHT (WARD 07)" and must be placed in the tender box at uMfolozi Municipality Offices at 25 Bredelia Street, Kwa-Mbonambi no later than 12h00 on the 17th & 24th of July 2015 when they will be opened in public.

A non-refundable tender deposit of R 250.00 per tender payable in cash or by a bank guaranteed cheque made out in favour of uMfolozi Municipality is required on collection of the tender documents. *No documents will be sold at the briefing session.* Only Service Providers with documents will be allowed at the briefing session.

The Municipality will accept no responsibility for late delivery of tenders by courier services or any other means. The lowest bid may not necessarily be accepted by the Municipality.

Bids shall remain valid for a period of 90 days from the closing date.
