Tenders are hereby invited in terms of Section 110 of the Local Government: Municipal Finance Management Act 56 of 2003 read with the Umfolozi Supply Chain Management Policy to submit proposals for the implementation of INEP Project for the period of 3 years starting **2019/2020** financial years. Consultants are required to indicate the **percentage fee/fee rates** that will be charged to render project management in terms of the Engineering Council of South Africa (ECSA) rates.

The scope of the work will include but not limited to completion of project include site assessment, preliminary design, survey, detailed design, tender document preparation, supervision, project management, closeout report and handover of project.

The closing date for the submission of proposals is Wednesday, **07 August 2019** at **12h00**. The tender box is situated at **Umfolozi Local Municipality offices on 25 Bredelia Street, Kwa Mbonambi 3915**. Telegraphic, telephonic, telex, facsimile, electronic and late proposals will not be accepted. All proposals must be submitted in a sealed envelope, clearly marked **"Consultants for the implementation of INEP projects for the period of 3 years"** and be deposited into the municipal tender box.

The tender will be adjudicated using the **80/20** preference point system of which **80** points will be for price and **20** points for BBBEE level of contribution.

The minimum point that must be scored by a bidder to proceed to the final stage of evaluation (price and preference points) is 70 points and failure will render bidder being disqualified from the tender process. Only bidders that pass the functionality criteria will be evaluated further.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;

 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.

- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
